Gleneagle Golf Course (GGC) is excited to offer group outings and tournament events for your group's specific needs! We offer a baseline package and a la carte options that allow you to craft your event to make sure you and your group have a great experience.

Gleneagle Golf Course also offers food and catering options to compliment the tournament event. These options vary from Taco Bars all the way to full Prime Rib dinners. Additionally, we have Breakfast Starter packages, Boxed Lunch packages, Brats at the turn, etc. Outside Catering is NOT available at this facility, all food and beverage must be purchased through Gleneagle or be approved to be given out at the facility.

Agreement Conditions & Terms:

The hosting company and event organizer are responsible for the proper conduct and attire for all participating players. Additionally, the hosting company and event organizer are liable for any damage caused by participating players to any other person, the golf course, clubhouse facilities, rented equipment and golf carts, and will be billed for said damage and any court cost and attorney fees. In accordance with Washington state law, the entire golf course is a licensed premise. It is unlawful to bring your own alcohol to the facility.



Fees Deposits:

Tournament organizers are required to provide GGC with a guaranteed attendance number at least 72 hours in advance of the tournament date. The guaranteed attendance number may not be less than the “minimum number of golfers” listed above. Prior approval is required for the guaranteed attendance to exceed the “maximum number of golfers”. You will be billed for the minimum guaranteed attendance number (the count we have 72 hours in advance of the function) or for the actual number in attendance, whichever is higher. No allowances are given. Shotgun starts require a minimum of 40 players. Similarly, once a total has been given for how many people will be eating, GGC will charge that number as a minimum and add any additional diners to the final bill.

Golf Course Terms:

GGC will endeavor to present the golf course in the best possible playing condition for your tournament; however, circumstances beyond our control may at times create less than ideal conditions. As long as the golf course is deemed playable and all 18 holes are available, no allowances will be given. Twice a year in Spring (March/April) or Fall (Sept), certain course maintenance procedures are required, including: aerification, top-dressing, over-seeding etc. This is done as weather permits and GGC cannot delay our schedule due to any pending event. GGC will not perform any of this maintenance on the actual day of your tournament and will make every effort to schedule normal maintenance as to not affect scheduled events. Weather dependent, a cart paths only play will be at the discretion of GGC.

Golf Tournament Weather Policy:

Because Puget Sound weather is unpredictable, all golfers should be prepared for adverse weather conditions. Due to multiple blocked tee times and the nature of rainy days in western Washington, tournaments will not be postponed, cancelled or refunded due to rain unless conditions making GGC unplayable force closure of the golf course.

Golf Course Rules and Regulations:

- The tournament is responsible to make sure that all golfers and guests adhere to the golf courses rules and regulations.
- Shirts and shoes must be worn at all times.
- All players must have a set of clubs and bag
- Practice on course is prohibited.
- No outside alcoholic beverages or coolers on site.



- Free relief from staked trees, yardage markers, sprinkler boxes and protective netting.
- Out of bounds is marked by red-tipped white stakes (which are played as lateral hazards) and course boundary fences. Trespassing is never allowing, doing so knowingly is grounds for immediate removal of the individual from the course.
- Power carts must be kept on the paths within 50 feet of tees and greens.
- Please replace divots. Repair ball marks on the greens by pushing inward on the divot not lifting from the bottom.
- The golfer is solely responsible for his or her actions on the golf course, including any damages caused to third parties or to a homeowner's property.

Pace of Play: We strive to have all patrons enjoy their game, so pace of play has a goal of a 4 hour 20 min round (14 min per hole). Slow play is defined by a group playing more than 1-½ shots behind the next group. The Player Assistant will notify any group if/when they are out of position and will do what he/she can to help the group get back into proper position. Unless the course is closed to other non-tournament players, tournament groups unable to keep pace will be asked to pick up their golf balls to regain their proper position in the field as part of our responsibility to others playing at GGC that day.

Acceptance:

I/we have read, accepted and agreed to all conditions of this agreement on behalf of the above named group or organization. I/we understand that there will be no written or verbal amendments or changes other than those referred to in this Agreement.

Golf Carts:

GGC golf cart fleet consists of 50 cars available for tournament use. Additional carts that are needed to accommodate the group must be reserved through us in adequate time to assure their availability. GGC is not responsible for non-availability of additional golf carts. If additional golf carts are rented, the group will be billed for all rented carts and any additional costs (including minimum deliveries, cancellation charges, etc.) incurred by GGC for the additional carts rented.

I/WE REPRESENT THAT I/WE AM/ARE FAMILIAR WITH THE OPERATION AND PROPER USE OF THE GOLF CART, AND THAT I/WE HAVE READ AND UNDERSTAND THE INSTRUCTIONS ABOVE REGARDING GOLF CARTS. I/WE AGREE TO INDEMNIFY, DEFEND AND HOLD LESSOR, THE GOLF COURSE AND ITS EMPLOYEES HARMLESS FROM ANY DAMAGES OR CLAIMS OF ANY NATURE WHATSOEVER THAT MAY ARISE FROM THE USE OR RENTAL OF THE GOLF CARTS.
